Hierarchical Storage Management

For organizations with storage cost concern, MessageSolution EEA efficiently offloads the data from expensive email server storage to inexpensive hierarchical archiving storage. It is a transparent process and there is no user-pattern change on the end-user client side, yet large portions of storage space are reduced both on the email and the archiving servers. & De-Duplication

MessageSolution also leverages In-Process Compression and Single-Instance-Storage to reduce storage requirements by up to 75% for the archiving server. After compression, archived data is stored in a secured format with various encryption options.
