



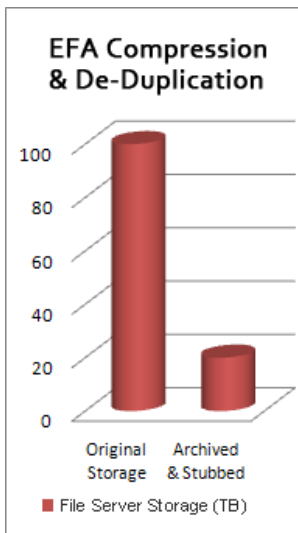

Reduce Storage Requirements

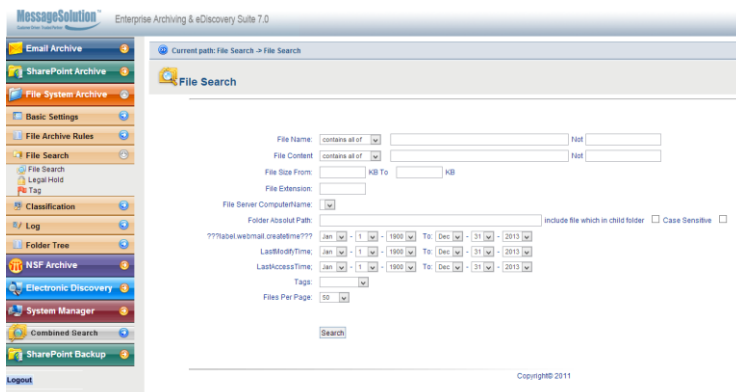
MessageSolution EFA efficiently offloads the data from expensive primary file server storage to inexpensive hierarchical archiving storage. There is no user-pattern change on the client side, yet large portions of storage space are reduced both on file servers as well as the file archiving server.

MessageSolution also leverages in-process compression and Single-Instance-Storage to reduce storage requirements by up to 60% on the archiving server.

Self-Serve Search & Data Restore

The MessageSolution Platform leverages full-text indexing search by full or partial File Name, Content, Size Range, File Extension, File Server,

Folder Path, File Creation, Modification or Access Time & File Tags. Users can also use Wildcard, Proximity and Fuzzy searching to account for phrasing or spelling inconsistencies, and restore archived files to their original location on the file server. EFA also recovers shadow copies - older versions of documents.

In addition to archiving the contents of candidate files, MessageSolution EFA transparently collects, replicates, compresses and indexes all data for advanced searching, eDiscovery and compliance management. The MessageSolution Platform supports over 400 file types including all popular formats. Archived data is almost immediately available for retrieval of business-critical situations, audits or eDiscovery requests.

With configurable and highly granular access controls, users can retrieve their own file data or legal team retrieve data from custodian accounts without IT involvement. After locating the necessary data, it can be restored to the file server, downloaded or compressed in zip files for delivery.

Built-In eDiscovery and Advanced Search

MessageSolution performs Fuzzy, Wildcard and Proximity searches for comprehensive data collection. In addition, it offers comprehensive eDiscovery features such as universal legal hold, configurable third-party legal/auditor access, folder-based file archiving and data collection.

MessageSolution also offers an advanced eDiscovery platform designed to delegate eDiscovery requests from IT back to the legal team. Features include Multiple Case Management, Case-Specific Access Authorization and Review Delegation, Legal Hold Notification, etc.

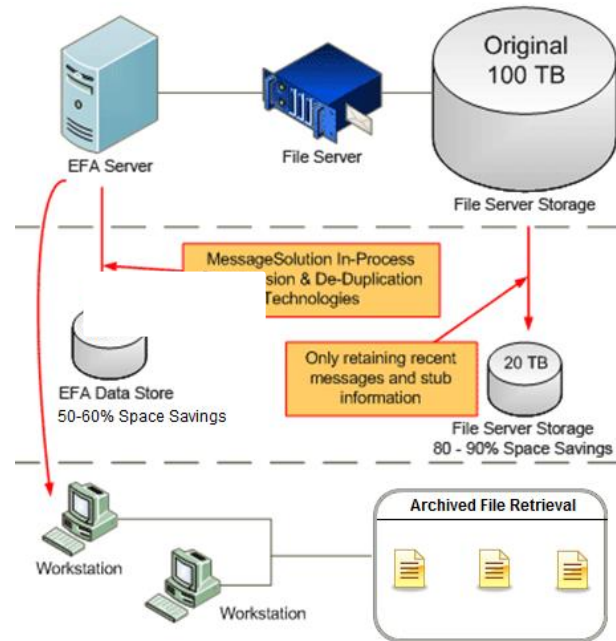
File Server to SharePoint Data Migration
